

# Our Global (ex-China) Policy Position on Charitable Giving

## BeOne's Position

At BeOne, we believe in a holistic approach to supporting patients and communities. Through our charitable giving, we aim to advance medical knowledge, improve disease awareness, and help address patient needs. Furthermore, we are passionate about supporting communities around the world and fund local initiatives in line with our mission to empower patients to live fuller, longer lives.

### **BeOne provides charitable giving through:**

**Donations** for non-profits, advocacy groups and NGOs that have an emphasis on cancer research, prevention, and treatment. This includes financial support for programs that benefit patients, families and caregivers who have been affected by cancer.

**Educational grants** for medical and scientific education programs or activities related to the therapeutic areas and disease states addressed by our medicines. We also finance initiatives that raise awareness among both physicians and patients about diseases and their available treatments.

**Forums** for the exchange of information including health-care related events or programs, such as industry association conferences and patient advocacy organization events. We support platforms for the advancement of scientific knowledge, the elevation of the patient voice and policy engagement across a range of stakeholders. This includes physicians, scientists, patients, drug developers and care providers.

## Applying for Charitable Giving

### **BeOne considers charitable funding requests from:**

Academic institutions, charities, foundations, patient advocacy organizations, NGOs and medical societies or associations.

## **BeOne does not consider charitable funding requests from:**

Organizations that discriminate on any grounds, such as race, religion, gender, gender expression, sexual orientation, age, disability, veteran or marital status or any other status protected under local law.

In addition, we do not fund certain requests, including those that support religious or political activities. The company does not provide charitable funds to individuals, public officials, political parties, trade unions, or entities subject to government sanctions. BeOne reserves the right to refuse charitable giving to charities or causes that it deems to violate the spirit of any of the above exclusions.

## **Application process:**

Requests are reviewed on an ongoing basis by a multidisciplinary team. Applications should be submitted through the BeOne charitable giving portal and approved at least 90 days in advance of the activity date. All our charitable giving processes comply with applicable rules, industry best practices and codes of conduct. This includes contracts with transparent fulfillment terms and internal controls to ensure against conflicts of interest. BeOne's charitable giving is not promotional, and we do not ask for a tangible benefit in return for our support.
